
**NOTIFICATION**

The Department has accorded approval towards payment of slab wise Transportation Charges with uniform rates for transportation of paddy (from purchase centres to tagged Rice Mills) and also intra-district as well as inter-district transportation of CMR (from Rice Mills to designated depots) from the Kharif Marketing Season 2022- 23, onwards, as per the following table:-

Sl. No.	Distance from Loading Point to Destination Point	Rates Per Quintal
1	<b>0 km to 8 Kms</b> (from Zero kms to less than or equal to Eight kms)	Flat Rate of <b>Rs. 25.67</b> (Rupees Twenty five and sixty seven paisa) only per quintal
2	<b>Above 8 kms upto 20 kms</b> (greater than Eight kms to less than or equal to Twenty kms)	<b>Rs. 25.67</b> (Rupees Twenty five and sixty seven Paisa) only per quintal upto 8 kms and further <b>Rs. 0.48</b> (forty eight paisa) only per quintal per km beyond 8 km to 20 km
3	<b>Above 20 kms upto 40 kms</b> (greater than Twenty kms to less than or equal to Forty kms)	<b>Rs. 31.43</b> (Rupees Thirty one and forty three Paisa) only per quintal upto 20 km and further <b>Rs. 0.44</b> (forty four paisa) only per quintal per km beyond 20 km to 40 km
4	<b>Above 40 kms upto 80 kms</b> (greater than Forty kms to less than or equal to Eighty kms)	<b>Rs. 40.23</b> (Rupees Forty and twenty three Paisa) only per quintal upto 40 km and further <b>Rs. 0.33</b> (thirty three paisa) only per quintal per km beyond 40 km to 80 km
5	<b>Above 80 kms</b> (above Eighty kms)	<b>Rs. 53.43</b> (Rupees Fifty three and forty three Paisa) only per quintal upto 80 km and further <b>Rs. 0.26</b> (twenty six paisa) only per quintal per km beyond 81 km and onwards.

The District Controllers, Food & Supplies shall certify the exact distance for processing of claim as Transportation Charges by Rice Millers.

This issues with the approval of the Finance Department vide their U.O. No. Group A-II/2023-2024/0224 dated 05.12.2023 and will remain in force until further order.
