NOTIFICATION

The State Government had earlier notified 501 (Five Hundred One) Centralized Procurement Centres (CPCs) in 1st phase vide Memo No. 3642-FS/Sectt/Food/4P-09/2023(Pt-II) dated 05.09.2023 and additional 11 (Eleven) CPCs in 2nd phase vide no. 3985-FS dated 26.09.2023 for purchase of paddy from the farmers during KMS 2023-24.

The State Government has now decided to set up another 22 (Twenty Two) CPCs in addition to the already notified 512 CPCs during the KMS 2023-24. Such CPCs will directly operate under the administrative control of the Director of DDP&S, Food & Supplies Department through the respective DCF&Ss.

The Governor is now pleased to notify these additional 22 CPCs as shown in the table below in 3rd phase for KMS 2023-24. Registration of farmers will continue along with other purchase centres and paddy purchase will commence from 1st November 2023. The Director of DDP&S and the DCF&S concerned will ensure that all the CPCs are fully functional for undertaking procurement of paddy from 1st November, 2023 positively.

Further, each CPC must have the requisite infrastructure for holding smooth paddy procurement operation and equipment, like moisture meters, electronic weighing machine(duly calibrated), computer (desktop /laptop) etc., to facilitate procurement of Fair Average Quality (FAQ) common paddy. In case the paddy is not lifted by the rice mills in time, adequate facility for temporary storage within the premises of the CPC must be identified to prevent any damage of the procured paddy. Each CPC must have a proper hoarding, displaying all relevant information for the farmers including FAQ paddy, MSP, documents required for registration etc. Details of the three men committee for resolving disputes (if any) should also be displayed at the CPC.

This issues in the interest of public service.
